Ms. Aden Hailu remains under the care of Saint Mary's Hospital in Reno, Nevada. 1. Mr. Gebreyes is the Guardian of Ms. Hailu and has authority pursuant to NRS 2. 159.079 to authorize medical treatment; approval of the Court is only required before the Guardian may consent to certain treatment consistent with the provisions of NRS 159.0805.

The Remittitur from the Nevada Supreme Court was issued on December 22, 3. 2015.

IT IS HEREBY ORDERED:

Pursuant to Nev. R. Civ. P. 35 and in conformance therewith, and pursuant to its 17 1. request in the motion for order to show cause, Saint Mary's is allowed to conduct two (2) 18 electroencephalograms ("EEGs") and any and all clinical neurological tests (save and except an 19 ocular vestibular test as further explained below) on Ms. Hailu prior to January 22, 2016. 20

Petitioner/Guardian has five (5) days to file any objection related to Saint Mary's 2. 21 conducting an ocular vestibular test and CT scan. Saint Mary's has five (5) days after the 22 objection is filed to file a reply. Thereafter, the Court will issue a decision whether Saint Mary's 23 is allowed to conduct the ocular vestibular test and CT scan prior to January 22, 2016. 24

The parties are granted leave to open discovery; production of the medical records 3. 25 should be ongoing. Discovery cut off is one week prior to the January 22, 2016 hearing. All 26 expert witness credentials and written reports will be exchanged at that time absent agreement of 27 the parties. 28
