We continue to celebrate our position as

a recognized leader in the health law community Since 2009, U.S. News and World Report has consistently ranked

Mitchell Hamline's health law program among the top 20 nationwide. In the 2018 edition, the Report named us the 11th best program in the United States and the top health law program in Minnesota.

We expanded access to health law education

Innovation and access are common threads that run through Mitchell Hamline's new strategic plan. HLI is proud to have actively carried out these strategies this year. We have pursued new partnerships that allow online MBA and visiting J.D. students to earn our certificates. Even more broadly, we rethought traditional teaching methods to bring our health law curriculum to students around the world. We have also committed to broadcasting our CLE events via live webcast and recording these educational opportunities so that they are conveniently available on-demand.

New experts joined our team of faculty Because we now offer many of our courses online, we have the unique opportunity to tap experts from across the country. For example, HLI Senior Fellow, Seth Whitelaw, President and CEO of Whitelaw Compliance Group, teaches online from Pennsylvania. Morgan Schacht '14, Compliance/ Privacy Officer in Mayo Clinic's Integrity and Compliance Office, teaches online from southern Minnesota. Of course, we are still using our bricks and mortar classrooms. For example, this summer, we welcomed Kate Johansen '09, Director of Government Relations for Medica, to the classroom for a condensed course.

Our alumni found meaningful careers Mitchell Hamline graduates have secured competitive positions across all sectors of the health care industry, including at: hospitals and clinics, insurance companies, law firms, consulting firms, state and federal government agencies, device and equipment manufacturers, and trade associations.

We hosted a number of compelling events The local legal and health care provider community earned hundreds of continuing education credits through events hosted by the HLI in 2017. These events covered topics such as: selling pharmaceuticals, food labeling, mental health, and healthcare cybersecurity and privacy.

EXTRAORDINARY MILESTONES



New partnership offers MBA in Health Care Compliance In partnership with Concordia University - Saint Paul (CSP), Mitchell Hamline now offers a Master of Business Administration with a Health Care Compliance emphasis. Students

will take the core curriculum (36 credits) of the MBA from CSP and the 11-credit health care compliance emphasis will be offered through MHSL. This online program will prepare students to skillfully lead a health care organization through the complex maze of government laws and regulations, and champion an ethical corporate culture.

New joint J.D. and Master in Public Health option

Students can now combine their Mitchell Hamline J.D. with a Master in Public Health from the University of Minnesota. Graduates will be equipped to identify public health law priorities, research, and draft laws that impact the public's health, and provide legal guidance in public health concerns. Through the dual degree, students can earn both degrees in just four years of full-time study.

Second start date offered for Health Care Compliance

Certificate A new cohort of working professionals began the Health Care Compliance Certificate in January 2017. Previously, this certificate program only began in May each year. This new start date allows for additional flexibility for busy working professionals.

HLI releases new publications: CHC Exam Toolkit and Health Care Compliance & the CHC Credential HLI

After successfully passing his CHC exam, Tyler Cowart '16, gathered feedback about the exam from alumni and compiled their advice. Graduates of the Health Care Compliance Certificate will receive the CHC Exam Toolkit. The Health Care Compliance & the CHC Credential document describes what it's like to work in health care compliance, why the CHC credential is beneficial, sector job growth, how MHSL prepares students, and tips for a successful compliance career.

Food Law Advisory Board forms Through the leadership of David Graham '87 a Food Law Advisory Board has formed at Mitchell Hamline. This group of industry leaders will make food law course, event, and program development recommendations.

Law and Leadership in Healthcare Administration

Certificate The Professional Legal Education program at Mitchell Hamline will be launching a new certificate: Law and Leadership in Healthcare Administration. This certificate will be offered fully online and is available to anyone who has earned their bachelor's degree or has equivalent work experience. The certificate will launch in March 2018 and will be 13 weeks in duration.

Sarah worked in the Minnesota Department of Health (MDH) Regulatory Division prior to law school. To gain more legal experience, and apply law school concepts, Sarah began clerking at Voigt, Rode, and Boxeth, LLC (VRB).

VRB represents long-term care providers licensed by MDH. In Sarah's opinion, "working for a law firm is one of the best opportunities for law students. I have been able to apply principles learned in the classroom to situations in the real world. I have had the opportunity to work on matters related to the independent, informal dispute resolution processes for nursing facilities that involve administrative law judges; conduct legal research and draft legal memoranda for matters related to skilled nursing regulations, contracts, liability, and negligence; and assist attorneys in material preparation for educational purposes. Overall, I have gained confidence and tacit knowledge through practice."

Christopher Griffin, MD, MBA, FACHE, completed Mitchell Hamline's online Health Care Compliance Certificate in May 2017 as a visiting J.D. student. He said, "I am a physician currently in law school on the West Coast, and was looking for more health law to

augment my legal studies. I have several decades of experience in health care, am a U.S. Veteran, and am a Fellow of the American College of Healthcare Executives. My plan is to return to the health care setting in a leadership position, and Mitchell Hamline's program was a very good fit.

At Pritzker Hageman, I get to work on a variety of cases with complex legal issues. I conduct legal research, compose arguments for motions to the court, and draft complaints. My favorite part of the job is advocating for our clients on a personal level by writing demand letters or mediation submissions articulating their experiences.

HLI has not only provided me with the training and education needed to succeed, but they have helped me foster relationships with professionals working in the field. It was at the HLI event "Hot Topics in Food Labeling and Safety" where I learned about Pritzker Hageman. HLI faculty continue to produce outstanding scholarship and lead scholastically

NYT features Professor Pope in story on unwanted resuscitation

The New York Times turned to Professor Thaddeus Pope in its recent reporting on end-of-life issues. The story "The Patients Were Saved. That's Why the Families are Suing." Appeared in the newspaper's April 10 edition.

Pope is one of the nation's foremost authorities on medical decisionmaking and end-of-life patient rights. The Times took note of a trend Pope has written about in The Journal of Clinical Ethics – doctors and hospitals are increasingly facing penalties and lawsuits for ignoring patients' advance directives and do-notresuscitate orders.

Professor Colombo to offer undergraduate health law course

Professor Barbara Colombo is creating a health law course that will be offered online to undergraduate institutions across the country beginning in January 2017. This course will cover public health law, medical malpractice, and food safety. It is meant to give undergraduate students a basic awareness of a broad range of health law issues and inspire them to join this growing field.

Hermer awarded Faricy Professorship

Professor Laura Hermer has been awarded a John H. Faricy Professorship for Empirical Research for the 2017-2018 academic year. Professor Hermer will work on a project analyzing the impact on client wellbeing as a result of receiving legal services through Mitchell Hamline's Medical Legal Partnership.

Professor Hermer receives grant to fund assessment of legal needs in St. Paul

Thanks to a grant from the American Bar Endowment, Mitchell Hamline's Medical Legal Partnership will be conducting a broad assessment of the legal needs of United Family Medicine's patients as well as residents in St. Paul's West Seventh Street neighborhood. Through the use of surveys and public listening sessions this fall, the partnership will identify pressing legal needs among patients and residents. Based on the results of the assessment, the partnership's clinical instructor. Ana Pottratz Acosta, and Mitchell Hamline students will host education sessions and offer clinical outreach to help residents better understand how to effectively tackle legal problems and offer them assistance in doing so.

"The grant will allow us to engage in dialogue with United Family Medicine patients and the surrounding community," said Laura Hermer, Mitchell Hamline professor and principal investigator on the grant. "The American Bar Foundation's generous support will allow us to get input from the community so we can better address their legal needs in these unsettled times."

Patients at United Family Medicine are predominantly low-income, and many are members of racial or ethnic minority communities.

I will also join Mitchell Hamline as an adjunct professor this fall for Professor Hermer's Health Law Organization and Finance course.

"While I came into law school with clinical health care experience, HLI provided an in-depth look into the legal aspects and inner workings of health care. From health care quality and liability, to organization and finance, regulations and risk analysis, HLI not only opened a window through which to view the complexities of our health care system, but provided hands-on experiential learning through externships and continuing education opportunities.

"One of the most valuable lessons I learned through the program was to view health law and health care more holistically. No area of health law is its own pillar. Rather, regulations affect patient care, liability, risk management, the bottom line, and so on. Changes to any one area can create a ripple effect that spills over into multiple other areas of health law. This more inclusive view helps me think critically and creatively about client's problems and the implications of potential solutions from multiple angles, rather than in a vacuum."

Experiential learning

HLI students receive hands-on, skills-based training through experiential learning opportunities in the health care industry

Experiential learning is the current that runs through the entire Mitchell Hamline curriculum. We decidedly integrate skills training, work experience, and career services throughout every facet of the law school. HLI strongly embraces this uniquely Mitchell Hamline approach to legal education.

HLI students are kept apprised of the wide range of experiential learning opportunities through Facebook, LinkedIn, Twitter, and the Student News. Through this regular communication, students are better informed of ways in which they can engage with the local bar and community health law events. These outlets also alert students to position openings, writing competitions and CLE presentations .



HEALTH LAW CLINIC: MEDICAL LEGAL PARTNERSHIP

The first of its kind here in Minnesota, Mitchell Hamline's Health Law Institute and United Family Medicine. a community-based clinic providing comprehensive, patient-centered primary care to low-income and medically underserved patients, launched a Medical Legal Partnership (MLP) in the fall of 2014. The MLP is staffed by a full-time attorney and incorporates a law school clinic that provides intake, counseling, and legal representation to low-income patients who need legal assistance as part of a holistic approach to their medical care. The MLP partners are extremely grateful to the F.R. Bigelow Foundation, Saint Paul Foundation, and Blue Cross Blue Shield Foundation for financial support. Over the 2016-2017 academic year. the MLP screened 139 referrals from United Family Medicine providers and accepted 23 new cases for full representation by the Health Law Clinic.

Immigration Advisory for Healthcare Providers

In December 2016, Ana Pottratz Acosta, MLP Managing Attorney, led an immigration law information session at United Family Medicine for the undocumented patient population. As a direct result of the information session, the MLP saw an uptick in immigration law referrals from providers. Following a series of executive orders and policy changes impacting immigration laws, along with rumored changes that would impact delivery of healthcare services to undocumented patients, the Upper Midwest Healthcare Legal Partnership Learning Collaborative published a white paper "Immigration Advisory for Healthcare Providers" co-authored by Clinical Instructor, Ana Pottratz Acosta. This advisory has been distributed to healthcare providers throughout Minnesota and is available on the Upper Midwest Healthcare Legal Partnership Learning Collaborative website (midwesthlp.org).

Medical Legal Partnership celebrates two successes

IMMIGRATION ASSISTANCE Mary is a U.S. citizen of Somali decent married to Jerry, a citizen of Somalia. After marrying Jerry in March 2016, Mary filed a pro se I-130 petition for alien relative with U.S. Citizenship and Immigration Services (USCIS) to sponsor Jerry for permanent resident status. Several months after filing the I-130 petition, Mary received a Request for Evidence (RFE) from USCIS, requesting additional evidence to show Mary and Jerry have a bona fide relationship, which was referred to the MLP for legal services. The MLP took on Mary's case for full representation and assisted her with preparing a response to the USCIS RFE. After submitting the response to the RFE on Mary's behalf, the I-130 petition was approved by USCIS and the file was forwarded to the U.S. Department of State for further processing and issuance of a permanent residence visa. The MLP then assisted Mary with collecting

and submitting documents to the U.S. Department of State in support of the visa application. Additionally, because Jerry was a citizen of Somalia, he was subject to the Travel Ban issued by the Trump Administration, which required additional steps to ensure continued processing of the visa application. Thankfully, in July 2017, the Department of State approved Jerry's case and he entered the U.S. as a permanent resident. Mary and Jerry were extremely happy to be reunited.

SOCIAL SECURITY ASSISTANCE Sally was recently diagnosed with Stage IV pancreatic cancer and required assistance with applying for Supplemental Security Income (SSI) benefits. Because of Sally's diagnosis, she was eligible for Terminal Illness (TERI) expedited processing of her claim. After being referred by her provider, Sally's case was accepted for full representation by the MLP. The MLP assisted Sally with electronically submitting her SSI application to the Social Security Administration (SSA), helped Sally collect medical records in support of her case, and accompanied her to the SSA office to submit evidence in support of her case and ensure her case received TERI expedited processing. Sally's case was approved shortly after the in-person visit to the SSA office.

Externships, internships, and other **opportunities**

Two Mitchell Hamline School of Law students and three graduates attended the Health Care Compliance Association's 21st Annual Compliance Institute March 26-29, 2017 in National Harbor, MD. The Compliance Certification Board generously donated the free registrations. The 2017 Compliance Institute welcomed more than 2,800 health care compliance professionals, offered 10 learning tracks, and featured more than 250 expert speakers.

Health Law Externship Through the Health Law Externship, students apply classroom learning to real-world experiences under the direction of an attorney mentor. These externships require a classroom component and 150 hours of field work. Health Law Residency The Legal Residency Program, only offered in the spring, builds on the success of the law school's well-established externship program. There, most students receive three to four credits. In a Residency, students earn 10 to 15 credits and work at least three full days each week at their residency site.

Judicial Externship Students can also engage in experiential learning by working for academic credit in a courthouse setting under the direction of a judge. Recent health law students have clerked for mental health courts and probate courts.

Internships Many Mitchell Hamline students convert their externships into internships, part-time jobs, and even full-time post-graduate employment. Mitchell Hamline students have recently interned at, among other places: Allina; Avera Health; Emily Program; Food and Drug Administration; Gillette Children's Speciality Healthcare; HealthPartners; Midwest Disability; Minnesota AIDS Project; Minnesota House of Representatives; Planned Parenthood; Prime Therapeutics; Public Health Law Center; St. Catherine University Office of Research; UCare; and Universal Hospital Services.

Part-time Jobs Many students in the Mitchell Hamline's part-time programs work full-time. Even full-time Mitchell Hamline students often work not just in the summer but also during the academic year. This gives them valuable experience and credentials. Students have recently worked at: Hallberg & McClain P.A.; Peterson Habicht; Moore, Costello & Hart; Nilan Johnson Lewis; and the Public Health Law Center.

Mentorship Program The Hachey Ambassadors Mentor Program for 3Ls and 4Ls matches students with experienced alumni working in areas of specific interest to the students. This creates a unique opportunity for our students to interact with leaders in the health law community. This program is managed by the Office of Alumni Relations and the Office of Career and Professional Development.

Pro Bono Health Law Experience Mitchell Hamline has a strong tradition of serving underserved communities. With the honor of a law license comes the responsibility to give back, in the form of legal services without compensation, to those who cannot afford to pay. Many Mitchell Hamline students choose to volunteer at health law related sites, such as: the Cancer Legal Line; Children's Dental Services; Minnesota Disability Law Center; and the Pathways Counseling Center. These placements are often facilitated by the Minnesota Justice Foundation.

Students engage in the Minnesota State Bar Association

Issues Conference Stephen Criffith '19, M.D. attended the ABA Physicians Legal Issues Conference in Chicago in June 2017. Dr. Griffith is a HYBRID J.D. student and said, "The conference was a great networking opportunity and reaffirmed that health law experts are in high demand."



The Public Health Law Center

In addition to the Health Law Institute, Mitchell Hamline is also home to the Public Health Law Center, a nationally-recognized nonprofit law and policy organization that helps health leaders, officials, and advocates use the law to advance public health. The combined resources of the Institute and the Center allow Mitchell Hamline to offer one of the most comprehensive health law programs in the country, providing access to more health law attorneys to guide student education than at any other law school in the nation.

The Public Health Law Center helps create communities where everyone can be healthy. The Center empowers its partners to transform their environments by eliminating commercial tobacco, promoting healthy food, and encouraging active lifestyles. Because the Center provides legal and strategic support to so many local and state health departments, health advocacy organizations, attorneys working on public health issues, and community coalitions across the country, they are helping drive many of the nation's cuttingedge public health initiatives.

Founded in 2000 by current Executive Director Doug Blanke as a 1-person institute at William Mitchell College of Law, the Center now employs 18 attorneys and 9 support professionals. For more information, visit www.publichealthlawcenter.org.

- The Public Health Law Center was honored to receive the 2016 Public Policy Award of the National Forum for Heart Disease and Stroke Prevention, in recognition of its contributions to tobacco control and healthy eating.
- Over the last year, the Center employed 32 student Research Assistants, presented 17 webinars on health-related legal topics, delivered more than 100 in-person presentations around the country, and published 6 articles in legal and medical journals.
- The Center prepared important amicus curiae briefs in a Supreme Court case testing the limits of First Amendment protection for price advertising, an Eleventh Circuit case on the authority of states to prohibit tobacco products, a Pennsylvania case on Philadelphia's power to tax sugary beverages, and a District of Columbia case on the FDA's authority to regulate electronic cigarettes. Among the many national organizations joining in the Center's briefs were the American Cancer Society, American Heart Association, American Lung Association, American Medical Association, American Thoracic Society, the National Association of County and City Health Officials and the National Association of Local Boards of Health.

PUBLIC HEALTH LAW CENTER



Doug Blanke, J.D. Executive Director

Doug Blanke is founder and director of the Public Health Law Center and chair of the Robins Kaplan Miller & Ciresi Endowed Directorship. He oversees all its programs, with a focus on encouraging healthier lives, including work to reduce the harm caused by tobacco use, prevent childhood obesity, support healthy eating, and encourage physical activity.

Blanke's international work has included monitoring development of the Framework Convention on Tobacco Control for the American Lung Association and editing the World Health Organization's handbook on tobacco control legislation. Previously, as an assistant attorney general of the state of Minnesota, he played a key role in the historic Minnesota litigation that resulted in the release of thirty-five million pages of secret tobacco industry documents. He was the 2004 recipient of the American Lung Association's C. Everett Koop "Unsung Hero" Award for his contributions to tobacco control.

Health Law Institute curriculum

In May 2017, the Health Law Institute awarded 5 Health Law Certificates and 20 Health Care Compliance Certificates. Every health law student is paired with a Health Law Institute faculty advisor to guide him or her through course and career planning. Since 2006, the Health Law Institute has awarded 131 Health Law Certificates and 187 Health Care Compliance Certificates.

Health Law Institute courses serve not only our certificate students, but also the broader law school community. During the 2016-2017 academic year, more than 350 students enrolled in more than 20 different health law courses.

These courses covered a broad range of topics, including: health care organization and finance, quality of care and liability, elder law, HIPAA privacy, medical malpractice, food and drug law, and bioethics. The following pages include a detailed overview of the Mitchell Hamline health law curriculum.

HEALTH LAW CERTIFICATE

The Health Law Certificate shows future employers that students have concentrated their studies in health law. Earning the certificate both requires and demonstrates a significant understanding and practical application of key health law concepts. The program design is consistent with the recommendations of the American Health Lawyers Association Health Law Curriculum Toolkit. More than 37 students are currently registered to complete the 17-credit program, which requires courses, experiential learning, and extracurricular engagement.

HEALTH CARE COMPLIANCE CERTIFICATE

Health Care Compliance Certification enables students to be uniquely positioned to make a positive impact as prepared and effective leaders in their chosen health care settings. The program provides a thorough examination of governing laws and regulations, introduces students to industry leaders, and offers hands-on learning and interactive simulations through its in-depth curriculum. The program is certified by the Compliance Certification Board. With Mitchell Hamline's Health Care Compliance Certificate, students are eligible to take the Certified in Healthcare Compliance (CHC) exam without satisfying the otherwise-required work experience and continuing education requirements. Mitchell Hamline was the recipient of the Society of Corporate Compliance and Ethics 5th Annual International Compliance and Ethics Award. More than 37 J.D. students are currently registered to complete this 14-credit program, and 19 students are currently enrolled in the 11-credit online program for working professionals.

VISITING STUDENT PROGRAM

Since Mitchell Hamline offers a more robust range of health law electives and opportunities than most law schools, law students from other schools visit Mitchell Hamline (in-person and online). In several recent instances, they have obtained certificates, externships, and permanent placements.

SUMMER AND JANUARY TERMS

The Health Law Institute attracts many non-traditional law students and health law professionals who are looking to advance in their current positions or to change careers. The compact online and on-campus courses offered over Summer and January terms offer an alternative to the regular academic calendar and accommodate busy work and family schedules. They also provide many law, graduate, and CLE students from outside Minnesota with the opportunity to take health law courses that are not available at their home campuses.

EVENING, WEEKEND, HYBRID, AND EXECUTIVE J.D.

The part-time evening, weekend, Executive J.D, and HYBRID J.D.SM enrollment options offer an alternative scheduling option for students. Mitchell Hamline offers more enrollment options than any other law school in the country. These programs are perfect for professionals who want to continue working while advancing or changing careers. They have attracted a number of health professionals such as physicians, nurses, compliance officers, and regulators. Health Law courses are scheduled so that evening, weekend, and HYBRID J.D. students can earn the Health Law Certificate and/or the Health Care Compliance Certificate.



Professor Pope works to calibrate the balance between individual liberty and

public health in the end-of-life medical treatment context. Specific research topics have included: medical futility, ethics committees, brain death, advance directives, surrogate decision making, aid in dving, and VSED. More recently. Pope has been innovating new legal tools to better assure adequate informed consent and fair internal dispute resolution mechanisms.

Professor Pope has over 130 publications in: leading medical journals, law reviews, bar journals, nursing journals, bioethics journals, and book chapters. He also coauthors the definitive treatise The Right to Die: The Law of End-of-Life Decisionmaking, and runs the Medical Futility Blog (with over three million page views).

Pope is also an Adjunct Professor with the Australian Centre for Health Law Research at Queensland University of Technology; Adjunct Associate Professor with the Alden March Bioethics Institute at Albany Medical College; and Visiting Professor of Medical Jurisprudence at St. Georges University. Prior to joining academia, Professor Pope practiced at Arnold & Porter LLP and clerked on the U.S. Court of Appeals for the Seventh Circuit. Pope earned a JD and PhD in philosophy and bioethics from Georgetown University.

Kahn received two grants from the National Human Genome Research Institute's (NHGRI) Ethical, Legal and Social Implications (ELSI) Research Program to support projects exploring the ethical and legal ramifications of the increasing use of racial and ethnic categories in the context of gene patenting and drug development. He is an internationally recognized expert on this topic.

He received a three year grant from the National Library of Medicine to support the writing of his newest book, Race in a Bottle: The Story of BiDil and Racialized Medicine in a Post-Genomic Age (Columbia University Press, 2013), which was awarded Honorable Mention for the 2013 Best Book Award, by the Race, Ethnicity, and Politics Section of the American Political Science Association. 

Interview with Jenny O'Brien, J.D., CHC, CHPC



What do you like best about working in health care compliance?

The role of a compliance professional is one of the most innovative and strategic positions I have held in my career. In my first compliance role I quickly learned it's not so much about the regulations or the seven elements of a compliance program, but rather about the

ability to develop a strategy for effective compliance and supporting others in implementing that strategy. It's about learning the barriers and challenges your colleagues have in meeting the regulatory obligations, and working with them to prevent, detect, and correct issues. Finally, it's understanding that the compliance model needs to follow the business model and while the seven elements remain the same, the strategy for implementing an effective compliance program for one organization is most likely not the right strategy for a different organization.

How does a law degree enhance your effectiveness as a compliance officer?

I use skills from my training as a lawyer every day in my compliance role. I became a better writer, a more strategic and objective thinker, and learned to view things from both sides, as well as articulate and communicate issues more effectively. Serving as an Assistant Attorney General provided a unique perspective into the role of the regulator, and respect for the job they are tasked with as stewards of the funds, and the oversight role they play for government programs.

What's one thing you wish you would have known while attending law school?

Trust your instincts and follow your passion. It gets a bit intense and competitive, and it's hard not to get caught up in all of it. It is so interesting to see the diverse and non-traditional paths many of my classmates have taken, as well as the contributions they are making within their various communities. I'd also encourage students to take advantage of all the resources the school offers. Follow-up with speakers and alumni, and take them up on their offer to meet. They wouldn't offer to share their experiences if they didn't mean it.

What value does Mitchell Hamline's health care compliance program provide students?

The compliance profession is evolving and growing. Mitchell Hamline recognized early the value of a health care compliance certification program. The role of a compliance professional wasn't on my radar when I went to law school. Mitchell Hamline 's program not only provides students a chance to explore if this is an area of interest, but also serves as a great resource for organizations across the country looking for candidates to fill positions.

Do you have any advice for students interested in working in health law or health care compliance?

It's a great career and there are many kinds of health care—hospitals, clinics, managed care, device companies, health care start-ups, home medical equipment, etc. Be curious, flexible, resourceful, and most importantly... network.
