DECLARATION OF ALEXANDRA SNYDER

I, Alexandra Snyder, am one of the attorneys for Jonee Fonseca, an individual and parent and guardian of Israel Stinson, a minor, in the District Court case from which the above-encaptioned interlocutory appeal was filed, and if called upon I could, and would, testify truthfully, as to my own personal knowledge, as follows:

1. On Saturday, May 21, 2016 at 5:30 a.m., Dr. Michael Myette and a medical team from Kaiser Roseville Medical Center ("Kaiser") assembled to assist in the transfer of Israel Stinson ("Israel") from the hospital. Kaiser attorney Jason Curliano was also present, as was I, representing Jonee Fonseca and Nathanael Stinson, Israel's parents.

2. An air transport team consisting of a registered nurse and a respiratory therapist, as well as a ground transport team, prepared Israel for transport with the assistance of Kaiser's medical team.

3. At approximately 7:30 a.m., Israel was transported by ambulance to McClellan Airport in Sacramento.

4. From there, Israel and his parents were transported by air ambulance to a hospital where he has been admitted as a patient.

5. Israel's parents signed an agreement releasing Kaiser and its staff from all liability involving Israel's transfer to another hospital once Israel was outside the doors of the facility in Roseville.

6. Israel Stinson and his parents arrived at the new hospital the afternoon of May 21.
