This bill closes a loophole in tate law that permitted doctros to place Do-Not Resuscitate Orders on patients without their consent. Protecting life in all its forms was an essential part of the Governor's special assession agenda.

"Patients' rights must be protected when it comes to decisions about their care," said Governor Abbott.
