Ethics/Medical Committee Reporting Form

According to Texas Health & Safety Code Section 1, Subchapter D, Chapter 166, health care facilities must report information regarding ethics or medical committee processes in instances in which an attending physician refuses to honor an advance directive or health care decision made by or on behalf of a patient. This reporting form must be filed with the Texas Department of Aging and Disability Services within 10th day after the written notice regarding the review process required under Section 166.046(d), as amended by 80(b)(1)HD 2162, is provided.

Information collected in this reporting form will only be used to meet statutorily mandated reporting requirements. Any patient information collected in this form is strictly confidential and will not be used to identify the patient by any means.

Questions within this reporting form refer to written notice required by [Health & Safety Code Section 166.046\(d\)](#), as amended by [80\(b\)\(1\)HD 2162](#), regarding ethics or medical committee review of a physician's refusal to honor an advance directive or health care or treatment decision. Additionally, Question 1 has been included to provide a contact person for HHSC in case any further inquiries arise on the reported information.
